**Series 2015**

October 6, 2015: Introduced as Council Bill 6, Series 2015 by Councilor Gallagher, seconded by Councilor Klasina VanderWerf and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

October 20, 2015: Considered in full text on second reading. Passed by a vote of 5 yes and 0 no.

**A BILL FOR AN ORDINANCE  
OF THE CITY OF CHERRY HILLS VILLAGE,  
AUTHORIZING A SUPPLEMENTAL APPROPRIATION FOR EXECUTIVE SEARCH FIRM  
EXPENSES IN FISCAL YEAR 2015**

**WHEREAS**, the City Council of the City of Cherry Hills Village adopted the 2015 budget and appropriated funds therefor in accordance with Article IX of the Home Rule Charter; and

**WHEREAS**, the City Council desires to hire an executive search firm to assist in the recruitment of a new City Manager; and

**WHEREAS**, the expenses related to the recruitment of a new City Manager through retention of an executive search firm were not budgeted or appropriated in the 2015 budget; and

**WHEREAS**, in accordance with Section 9.10 of the Home Rule Charter, the City Council desires to make an additional appropriation for the unanticipated expenditure of an executive search firm to assist the City in hiring a new City Manager.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:**

Section 1. That the 2015 Budget and Appropriations is hereby supplemented by increasing the following fund and account by an additional amount of \$24,000, to-wit:

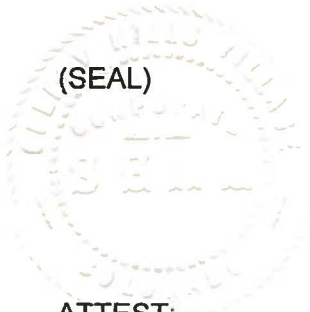
