November 20, 2012: Introduced as Council Bill 15, Series 2012 by Mayor Pro Tem Stewart, seconded by Councilor Griffin and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

December 11, 2012: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE OF  
THE CITY OF CHERRY HILLS VILLAGE, COLORADO AUTHORIZING APPROPRIATIONS  
FOR FISCAL YEAR 2013**

**WHEREAS**, the City of Cherry Hills Village has prepared and approved a Budget for fiscal year 2013 and the City is authorized and required to make appropriations by ordinance for each fiscal year pursuant to Article IX of the Charter of Cherry Hills Village, and

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:**

Section 1. From the monies obtained from taxation and from all other sources of revenue of the City of Cherry Hills Village, Colorado, during the year beginning January 1, 2013, and ending December 31, 2013, there is hereby appropriated the following sums for the following funds, to-wit:

General Fund	5,947,205
Capital Fund	991,925
Land Donation Fund	620
Conservation Trust Fund	35,000
Special Improvement District No. 7	83,369
Water & Sewer Enterprise Fund	153,767
Arapahoe County Open Space Fund	139,000
Parks and Recreation Fund	1,629,859
<b>TOTAL</b>	<b><u>\$ 8,980,745</u></b>


Section 2. The City Council may, by resolution, transfer any unexpended balance in any of the above mentioned funds to any other fund mentioned or to reserves.

Section 3. The City Council, pursuant to Article XX of the Colorado Constitution, deems that this ordinance supersedes the provisions of C.R.S. 29-1-301, and that said statute is inapplicable to the matters addressed by this ordinance.

Section 4. Should any section, clause, sentence or part of this Ordinance be adjudged by any court to be unconstitutional or invalid, the same shall not affect, impair or invalidate the ordinance as a whole or any part thereof other than the part so declared to be invalid, except to the extent that such invalidation defeats the purpose and intent of the City Council in adopting this ordinance.
