February 2, 2010: Introduced as Council Bill 4, Series 2010 by Councilor Scott Roswell, seconded by Councilor Mark Griffin, and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

February 16, 2010: Considered in full text on second reading. Passed by a vote of 4 yes and 0 no.

A BILL FOR AN ORDINANCE
OF THE CITY OF CHERRY HILLS VILLAGE
AMENDING CHAPTER 6 OF THE CHERRY HILLS VILLAGE MUNICIPAL CODE,
CONCERNING BUSINESS LICENSES, BY AMENDING ARTICLE I,
CONCERNING REQUIREMENTS FOR OBTAINING BUSINESS LICENSES

WHEREAS, the City of Cherry Hills Village is a home rule municipal corporation organized in accordance with Article XX of the Colorado Constitution; and

WHEREAS, the City Council has determined to amend the City of Cherry Hills Village Municipal Code ("Municipal Code") to clarify the requirements for obtaining business licenses.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

That Section 6-1-10 of the City of Cherry Hills Village Municipal Code is hereby amended to read as follows:

Sec. 6-1-10. Purpose.

The purpose of this Article is the regulation and registration of businesses (as defined in Section 4-4-10) operating within the City for the health, safety and welfare of the citizens of the City and for the proper collection of taxes to support the City.

That Section 6-1-20 of the City of Cherry Hills Village Municipal Code is hereby amended to read as follows:

Sec. 6-1-20. License required.

Every person must obtain a license from the City before operating, conducting or carrying on any retail trade, profession or business with a physical store front within the City (zone C-2); except that nonprofit state corporations, excluding federal, state or municipal corporations, are hereby exempt from the license requirements set forth in this Article.

That Section 6-1-30 of the City of Cherry Hills Village Municipal Code is hereby amended to read as follows:

Sec. 6-1-30. Separate license for each location.

Any ~~person~~ store front business operating, conducting or carrying on any retail trade, profession or business within the City must obtain a separate license for each location of such trade, profession or business.
