Colorado Revised Statutes Section 31-10-302: Nomination petitions may be circulated and signed beginning on the 91<sup>st</sup> day (August 9, 2022) and ending on the 71<sup>st</sup> day (August 29, 2022) prior to the day of election. Petitions shall be filed with the City Clerk no later than the 71<sup>st</sup> day (August 29, 2022 at 4:30pm) prior to the day of election. Cherry Hills Village Home Rule Charter Section 2.8: The nominating petition for each candidate for Mayor shall be signed by not fewer than 25 registered electors, and for the Council to be elected from a district not fewer than 10 registered electors from such district.
