Dear Cherry Hills Village,
We are writing in support of the proposal by Katy Brown that removes proposals for transferring title.

In light of this new information, I propose that City Council modify the RFP process to remove consideration of proposals that contemplate transfer of title and permit proposers, if they so choose, to submit a revised proposal to the City in compliance with that change on or before September 14, 2021.

RECOMMENDED MOTION "I move to modify the process for the Quincy Farm Management and Programming RFP by deleting the fifth paragraph from the "Conditions and Restrictions" section on page 7 of that RFP and replacing that paragraph with the following language: 'The City will not entertain proposals that contemplate transfer of title to the Property.' I further move that any proposer that wants to modify its proposal to eliminate transfer of title to the property and propose an alternate plan may submit a revised proposal to that effect to the City on or before September 14, 2021."

We have written previously to express our support of continued public ownership of Quincy Farm.
We think this is an important resource for Cherry Hills Village as public and historic open space.
