

**ORDINANCE NO. 17**  
**Series 2010**

May 18, 2010: Introduced as Council Bill 13, Series 2010 by Councilor Scott Roswell, seconded by Councilor Klasina VanderWerf, and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

June 1, 2010: Considered in full text on second reading. Passed by a vote of 5 yes and 0 no.

**A BILL FOR AN ORDINANCE**  
**OF THE CITY OF CHERRY HILLS VILLAGE**  
**AMENDING CHAPTER 1 OF THE CHERRY HILLS VILLAGE MUNICIPAL CODE,**  
**CONCERNING GENERAL PROVISIONS, BY AMENDING SECTION 1-6-10,**  
**CONCERNING THE LOCATION OF CITY OFFICES AND RECORDS**

WHEREAS, the City of Cherry Hills Village is a home rule municipal corporation organized in accordance with Article XX of the Colorado Constitution; and

WHEREAS, Section 1-6-10 of the Cherry Hills Village Municipal Code designates the Village Center as the office of the City and states that all books and records of the City shall be kept in said office; and

WHEREAS, due to limited space at the Village Center the City has found it necessary to store some of its books and records at a separate location; and

WHEREAS, the City Council has determined to amend the City of Cherry Hills Village Municipal Code ("Municipal Code") to authorize the storage of books and records at other locations.


NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. That Section 1-6-10 of the City of Cherry Hills Village Municipal Code is hereby amended to read as follows:

**Sec. 1-6-10. Location of City offices, records.**

The office of the City shall be located in the Cherry Hills Village Center at 2450 East Quincy Avenue, Cherry Hills Village, Arapahoe County, Colorado. All books and records of the City shall be kept in said office or, in the discretion of the City Manager or his designee, at a separate location from which the City's books and records are easily retrievable. (Ord. 20, 1968; prior code 1-5-5)
