

FREQUENTLY ASKED QUESTIONS

Can my membership to the YMCA be submitted for reimbursement?

No, the YMCA is not a municipal or special district recreation department.

Can my membership to the Greenwood Athletic Club be submitted for reimbursement?

Yes, The Greenwood Athletic Club formed as a special district recreation department effective March 17, 2005. Any costs incurred after the formation of the special district will be honored.

Can I submit my childcare costs for reimbursement?

No, childcare is not considered a recreation program, activity, class or event.

Can I submit for reimbursement a receipt for a \$100 ice skating class that my daughter is taking through South Suburban Recreation District?

Yes, the amount of the reimbursement will be \$50 (50 percent of the cost incurred not to exceed a maximum of \$50.00 per single activity) as long as you have not exceeded the maximum reimbursement for all recreation activities of \$500.00 per household.

Can I submit my golf cart fees for reimbursement?

No, we do not reimburse for equipment, only the activity.

Which golf courses are eligible for reimbursement?

Any golf course that is a municipal or special district golf course in the seven county metro area. A listing is provided below, click on "Golf Course List." Please note that the list is not a comprehensive list. If you have any questions, please ask the golf course.

I purchased an annual pass for my family, how much is my reimbursement?

The amount of your reimbursement will be 50% of the purchase price up to \$500 total reimbursement (example: if you purchased a family pass for \$1,000 your reimbursement would be 50% or \$500 less any reimbursement you have already received.

Can I submit my receipts for classes from the previous year?

No, reimbursements are only eligible for the current calendar year.

When do I need to have my 2007 receipts turned in for reimbursement?

All 2007 requests for reimbursement must be received at the Village Center, 2450 E. Quincy Ave. before 4:00pm on Thursday, January 31, 2008.

Can I submit a photocopy of my receipt?

No, an original receipt is required.

Can I submit a credit card receipt for reimbursement?

Possibly, if the credit card receipt has an itemized listing of the expenditure.

Where can I get a recreation reimbursement form and instructions?

Forms and instructions are available at the Village Center and by clicking below on "Recreation Reimbursement Form."

May a resident donate their recreation reimbursement using the recreation reimbursement form?

Yes, Council has approved the donation of your households recreation reimbursement, via a donation check off, to the Village's Land Donation Fund. This Fund has been established expressly to purchase and maintain Village open spaces, parks and trails. Please refer to the bottom of the recreation reimbursement form for directions.
