## CITY FLOODPLAIN DEVELOPMENT REGULATIONS AND NATIONAL FLOOD INSURANCE PROGRAM REQUIREMENTS

Since 1978, the Village has participated in the National Flood Insurance Program (NFIP) Community Rating System (CRS), making residents eligible for federally backed flood insurance and flood insurance discounts. In order to participate in this discount program, the Village has adopted minimum standards and regulations for floodplain development, conducts regular drainage way maintenance and provides community outreach on floodplain issues. There are approximately 200 properties in the Village that intersect a floodplain designated on the FEMA Flood Insurance Rate Maps (FIRMs) adopted by the City. If the residential structure on the property is located in a floodplain, flood insurance will be required by most mortgage lenders.

In Cherry Hills Village, most development in the floodplain is prohibited unless a special development permit is granted by the City Council. If you want to know if your property is in the designated floodplain or for more information



on floodplain development permit requirements you can contact the Cherry Hills Village Community Development Department at (303) 783-2721 or stop by the Village Center at 2450 E. Quincy Avenue. The Village keeps records of all current and past adopted floodplain maps and Flood Hazard Area Delineation (FHAD) areas, flood depth data for most currently mapped areas of the Village, and FEMA issued elevation certificates.

### Helpful Tips...

The following are helpful tips for residents who live in flood prone areas:

- Know the extent and nature of the flood hazard in your area.
- Plan escape routes to high ground.
- Buy flood insurance for your property.
- During times of heavy rainfall watch the level of water in the drainage way and stay tuned to radio or television for possible flood warnings.
- Evacuate the flood hazard area in times of an impending flood.



weekend is coming up in September! The Cherry Hills Land Preserve will host their 6th Annual Barn Party on Saturday, September 17 at the beautiful Rady barn, followed by the Barn Tour on Sunday, September 18th.

The festivities kick off with everyone's favorite neighborhood gathering at 6:30 p.m., with fun, western-inspired food, an open bar, a cocktail designed especially for the event, live music, and a silent auction featuring some of the region's best artists and craftsmen. The Barn Party is an opportunity to gather, see neighbors and friends, and celebrate the rural heritage and landscapes we all love in the Village. On Sunday, the Barn Tour from 11 am - 2 pm is a wonderful family event with a map of possible routes to ride bikes, walk, or drive to the different barns and enjoy a great day on CHV's trails and celebrate our open spaces. For 2016, we have five captivating barns around our community including Quincy Farm, a 17.5 acre gem in the heart of the Village with a conservation easement to protect it in perpetuity, an innovative passive-solar design greenhouse, and several other unique barns that remind us of our semi-rural and equestrian past. In addition, there will be a Farmer's Market at the Village Center with fresh produce and crafts.

Both weekend events benefit The Cherry Hills Land Preserve, a local non-profit organization whose purpose is to inspire protection of natural open lands in Cherry Hills Village.

### **Why does CHLP host the annual Barn Party & Tour?**

To celebrate the Village's unique rural heritage and natural landscapes in an increasingly urban landscape, and to encourage both old and new residents to value and protect them in the face of increasing urban development across Colorado. Did you know Cherry Hills Village has more than 46 miles of public trails? Or that Cherry Hills Village Elementary began as a one-room

schoolhouse in 1886, built on a dirt path that later became Quincy Avenue? Cherry Hills Village's history of family farms and homesteads with large open lands helped shape the natural open lands and trail system we enjoy today, and that CHLP works to protect and enhance.



## CHARLO DEDICATION

**U**nder clear blue Colorado skies, on June 16, dozens of Villagers gathered on the lawn in front of the Joint Public Safety Facility to dedicate and celebrate the Village’s magnificent art sculpture, Charlo, a bronze horse by Deborah Butterfield. Cherry Hills Village Public Art Commission Chair Ann Polumbus began the afternoon program by saying, “We asked you to ‘Imagine a Butterfield.’ And you did!” The Art Commission points to the Butterfield horse as the Village’s signature piece of art.

Following introductions, the crowd reconvened in the Community Room where Mayor Laura Christman spoke, along with the Village’s new City Manager, Jim Thorsen. A stunning glass plaque, that highlights the names of the over-200 Villagers whose gifts helped purchase Charlo, was also on display. A reception at the home of Rosalina and Richard Diecidue followed the ceremony.

## “High Line Canal Trail Resurfacing Project”

In the month of August, the City of Cherry Hills Village Public Works Department will be resurfacing the entire 3.2 miles stretch of High Line Canal Trail (at the time of press, the specific dates and times had not been set). The project will consist of installing a new layer of granite sand and crusher fine material. The new layer of material will make for a brand new wearing surface that will be free of large ruts and depressions that present safety hazards for users. The overall goals of the project is to keep users safe, improve the appearance and extend the useful life of the High Line Canal Trail for many years to come. ## 2016 ELECTION TIMELINE

### August 9, 2016

First day candidate nomination petitions may be circulated; Candidate packets available at the Village Center and on the City website

### August 29, 2016

Candidate nomination petitions are due to the City Clerk by 4:30 p.m.

### September 2, 2016

Last day nomination petitions may be amended; last day for a candidate to withdraw; last day an Affidavit of Intent for Write-In Candidate may be filed with the City Clerk

### September 6, 2016

Draw lots for candidate order on ballot; last regular Council meeting before final ballot content due to County

### September 9, 2016

Final ballot content due to County

### October 17, 2016

Ballots mailed to each registered voter

### November 8, 2016

**ELECTION DAY**

### January 3, 2017

Newly elected Cherry Hills Village officials are sworn in and take office



- Resident of the district the candidate wants to represent. Any person elected as a City Council member must continue to live within the district for which he or she was elected throughout the term of office. The Mayor need only continue to live within the City.

## CODE ENFORCEMENT

**T**he Code Enforcement Department sends out notices for weeds that are over ten inches in height. If the problem is not corrected, the owner can be cited with a citation to appear in Municipal Court.

Other common complaints for Code Enforcement are: uncovered trash, piles of branches, left over construction material, broken fences, trees and bushes growing in the right-of-way and/or obstructing traffic views at intersections, and dead or diseased trees.

As a reminder, residents who have landscaping crews at their property must let them know that the City does not allow dumping or storage of any landscaping materials (i.e. mulch, dirt, rocks, etc) on City streets or in rights-of-way. Residents should also make sure that roll-off dumpsters or port-a-lets are not placed on any City streets or in the rights-of-way.
