Series 2021

November 16, 2021: Introduced as Council Bill 16, Series 2021 by Mayor Pro Tem Katy Brown, seconded by Councilor Mike Gallagher and considered in full text on first reading. Passed by a vote of 5 yes and 0 no.

December 8, 2021: Considered in full text on second reading. Passed by a vote of 4 yes and 0 no.

**A BILL FOR AN ORDINANCE
OF THE CITY OF CHERRY HILLS VILLAGE,
AMENDING THE 2021 BUDGET AND APPROVING A
SUPPLEMENTAL APPROPRIATION IN THE GENERAL FUND AND
THE PARKS AND RECREATION FUND FOR EXPENDITURES
RELATED TO THE PUBLIC AFFAIRS CONSULTANT
PROFESSIONAL SERVICES AGREEMENT**

WHEREAS, Ordinance 8, Series 2020 and Ordinance 9, Series 2020 approved the 2021 budget and appropriated funds in accordance with such budget; and

WHEREAS, Section 9.10 of the Cherry Hills Village Home Rule Charter, entitled Additional Appropriations, authorizes City Council to make additional appropriations by ordinance during the fiscal year for unanticipated expenditures required of the City; and

WHEREAS, at the October 5, 2021 City Council meeting, City Council approved a Professional Services Agreement with Blakley + Company LLC for public affairs consulting services; and

WHEREAS, the anticipated expenditures the City will incur in 2021 were not included in the original budget approved in 2020; and

WHEREAS, the City has agreed to pay a portion of the public affairs consulting in 2021, in a not-to-exceed amount of \$28,175; and

WHEREAS, \$22,821.75 of the not-to-exceed amount will be expended from the General Fund and \$5,353.25 will be expended from the Parks and Recreation Fund; and

WHEREAS, in accordance with Section 9.10 of the Charter, the additional appropriation contemplated herein does not exceed the amount of estimated and actual revenues in budget year 2021.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. That the 2021 Budget and Appropriations is hereby supplemented by increasing the following fund by an additional amount of \$28,175, to wit:

General Fund



Section 2. The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.

Section 3. Effective Date. This Ordinance shall become effective ten (10) days after publication on second reading in accordance with Section 4.5 of the Charter for the City of Cherry Hills Village.


