RESOLUTION  
OF THE CITY COUNCIL  
OF THE CITY OF CHERRY HILLS VILLAGE  
ADOPTING NEW FEES FOR THE SEWER SYSTEMS  
OWNED AND OPERATED BY THE CITY**

WHEREAS, the City of Cherry Hills Village has a duty and responsibility to its citizens to protect the public health, safety and welfare of its residents; and

WHEREAS, the City operates a sanitary sewer system that serves certain users within the City; and

WHEREAS, pursuant to C.R.S. Section 31-35-402(1)(f), the City is authorized to impose and collect fees from users of the City sanitary sewer system; and

WHEREAS, the City of Cherry Hills Village desires to provide and maintain sanitary sewer transmission lines that meet the needs of the citizens served by these facilities now and in the future; and

WHEREAS, the City of Cherry Hills Village must have sufficient reserves to repair and maintain the sanitary sewer transmission lines; and

WHEREAS, the cost to repair and maintain these lines must be the responsibility of the users who tap into and are serviced by the City's sanitary sewer transmission lines; and

WHEREAS; the cost to maintain and repair these lines has increased substantially, and the City desires to impose rates and fees on users that will cover the cost of repair and maintenance of the City's transmission lines.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE:

Section 1. That the fee schedule dated November 18, 2014, and attached hereto, is hereby adopted as the official sewer fees for the City of Cherry Hills Village, Colorado.

Section 2. This Resolution shall be effective immediately.
