Colorado Revised Statutes Section 31-10-302: Nomination petitions may be circulated and signed beginning on the 91st day (August 9, 2022) and ending on the 71st day (August 29, 2022) prior to the day of election. Petitions shall be filed with the City Clerk no later than the 71st day (August 29, 2022 at 4:30pm) prior to the day of election. Cherry Hills Village Home Rule Charter Section 2.8: The nominating petition for each candidate for Mayor shall be signed by not fewer than 25 registered electors, and for the Council to be elected from a district not fewer than 10 registered electors from such district.

WARNING: IT IS AGAINST THE LAW:

For anyone to sign this petition with any name other than one’s own or to knowingly sign one’s name more than once for the same candidate or to knowingly sign the petition when not a registered elector. Do not sign this petition unless you are an eligible elector. To be an eligible elector you must be registered to vote and eligible to vote in City of Cherry Hills Village elections. Do not sign this petition unless you have read or have had read to you the nomination petition in its entirety and understand its meaning.
